Members of the public present advised that they were interested in the Hill Farm matter which was due to be raised under the Neighbourhood Development Plan Agenda item.

### 064/15 PLANNING

Members considered the following planning applications submitted to Colchester Borough Council:

151633 - Land adjacent Earlwood House Chapel Road Boxted - Outline planning application with all matters reserved for the erection of two semi-detached dwellings. It was noted that this application had been withdrawn.

151565 – Extension to existing stable block and new swimming pool within the domestic curtilage of Boxted Farm Lodge - NO OBJECTIONS

#### **NEIGHBOURHOOD DEVELOPMENT PLAN**

065/15 The Chairman allowed members of the public to take part in the debate and the three people present advised that they felt that the wording of the questionnaire was biased and took no account of the Planning Inspector's opinion and that the problems with delivery meant that this would not be a valid exercise. It was explained that this was not a scientific exercise and it was designed to gauge public opinion only, not provide conclusive answers and that the results of the questionnaire would be considered alongside many other consultations that have happened over the past two years throughout the NDP project. It was explained in detail that this was privately owned land and that our NDP cannot force the landowner to do anything. All it can do is to seek to influence the landowner to produce the best possible option for Boxted Village. Councillor Mrs Wells volunteered to review the questionnaires and would take into account e-mails received on the matter and hand written letter and suggestions attached to returned questionnaires. It was acknowledged that despite efforts to try to ensure that multiple replies could not be sent by one person the system used and the two mailings meant this could not be guaranteed but Councillor Wells advised that she would look for trends and similar handwriting in responses, to try to ensure that there were not numerous duplicates from the same source.

# 066/16 SPORTS PAVILION

The Clerk reported that all essential work was now completed and the sports changing facilities were now ready to be used and have been made available for the Sports teams from today's date. The Cricket Club still have not signed their hire agreement, so will not be using the facility until this has been received. Councillors agreed to view the refurbishment to date after the meeting.

The Clerk reported that we had interest from a local childminder who wished to hire the lounge/back kitchen area to provide 'wrap around' childcare in the form of a breakfast club and after school club and the Council agreed they were supportive of this idea which would generate much needed income for this facility. It was noted that the Clerk would be applying for grant funding to finish the refurbishment of these areas.

The total cost to date for the Council has been £25k, another £20k is needed for the bar/lounge and back kitchen area and then further monies for external repairs.
