BOXTED PARISH COUNCIL MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD ON 10 JULY 2019 AT THE VILLAGE HALL AT 7.30PM

19/0106 Welcome

19/0107 Apologies and reasons for absence.

Cllr Damen, Oxford and Pugh had sent apologies and the Council resolved to accept them.

19/0108 Declaration of Interests - to receive any pecuniary or non-pecuniary interests relating to items on

the agenda.

None were declared.

19/0109 Public participation session with respect to items on the agenda and other matters that are of mutual interest.

Most members of the public attending had come to air concerns regarding the possible development of the CBC owned garage site for housing. There was concern that it would provide access to the field behind, opening the way to more housing development. Cllr Arnold was able to confirm that the current adopted Local Plan, the emerging Local Plan and the adopted Boxted Neighbourhood Plan did not have the field behind in scope for any development and any planning application would likely be refused. There was a lot a concern raised about the access onto Dedham Road and the increase in danger any additional vehicle traffic and the location of the entrance would make. There was also the possibility that the public footpath would be diverted and increase the risk of danger for children walking to and from school. On that topic Cllr Anne Brown confirmed that she was meeting a highways representative in Boxted at school pick up time so look at the problems which have been exacerbated by the closure of the school car park. She invited the Parish Council to join her.

There were questions raised about suitability of any garage-site built housing for local residents and disabled people and these were questions that would need to be raised at any planning application stage.

Cllr Collitt summed up the discussion by saying that the site was unsustainable due to lack of parking, no regular bus service, no shops, no pub, no pharmacy or GP, and a full school. These were points that would be expressed to CBC

Mrs Carter asked if, when the Parish Council secured the Village Green, the Council would erect 2 memorial benches to her husband and father in law who served the village of Boxted and the Parish Council. Mr Denis Carter built up the fruit farm to over 1000 acres and his son Jeremy Carter also ran the farm and served for many years on the Parish Council.

19/120 The next Item was taken out of order Village Green

To note the progress towards establishing a village green and to consider memorial benches.

The Council <u>resolved</u> to put 2 benches on the new Village Green in memory of Mr Dennis Carter and Mr Jeremy Carter.

The clerk confirmed that the developers had been approached for confirmation of transferring the green to the Parish Council and Fisher Jones Greenwood are representing the Council for this. The electric point needs to be organised and the developers are aware of the requirement. The Council has confirmed that it will pay any costs that are due. The tree planned for the centre of the green needs CBC permission to not plant as it forms part of the planning consent. The

Council resolved to ask CBC to remove this tree in the plans. Post meeting note CBC confirmed that they were content that the centre of the Green not have the large tree planted.

The Council resolved to accept the minutes as an accurate record.

19/0111 Clerk's Report

To receive the report of resolutions agreed at Parish Council Meetings and Progress to date.

The clerk sought an update on the plan to ask a local landowner if a footpath could be diverted around the edge of a field (rather than across the crops) and to upgrade the path to a bridleway. Cllr Collitt advised that the landowner was not keen to upgrade to a bridleway but would be happy to divert the footpath.

The clerk also advised that the Parish Council would need to initiate the a Committee or Working Group to develop plans for the S106 funding that had been allocated to Boxted. It was resolved to schedule the formation of a Committee at the September 2019 meeting and to encourage residents to get involved.

19/0112 **Borough and County Council**

To receive the reports of the District Councillor and the County Councillor.

Cllr Chapman suggested if a Rural Exception Site is planned to be developed then the Council should consider other housing development companies and sites and not just look to the Rural Housing Partnership.

Cllr Chapman also said that the CBC Local Plan was being progressed through the summer as should be published in the Autumn.

19/0115 Rural Exception Sites (RES) and a Housing Needs Survey (HNS)

To also discuss possible concerns that might apply to a Boxted RES.

To note that a visit to the RES site in Boxford should now take place in September.

RCCE are quoting for the assistance with conducting a Housing Needs Survey to approximately 579 dwellings.

The aim of an HNS survey is to establish the future requirement for affordable housing for residents in the parish. This might then inform the need for a Rural Exception Site to be identified and supported. The last HNS was conducted in 2013 and is time expired. The Council agreed that a Housing Needs Survey could be used to also ask residents of concerns that they may have about a Rural Exception Site.

The visit to Boxford RES was noted as 16th September 2019.

An HNS survey requires putting through all parish dwellings and making available in public places, which the Council will have to arrange. The RCCE has quoted a cost for printing the surveys, collecting and analysing the data (variable cost depending on the number of questionnaire responses received) of up to £435.00 and the Council <u>resolved</u> to conduct a Rural Housing Needs Survey via the RCCE and look to add two questions about village and housing concerns.

19/0116 Village Parking

It was reported that Councillors had met with the North Essex Parking Partnership and Cllr Brown was meeting with ECC Highways to discuss the increased road parking in and around Boxted Cross.

19/0117 King George Playing Field
