The latest reports from the various consultants were noted. Also noted that in due course a very substantial sum needed to be spent on the premises. However for present purposes it was noted that in the update as at 1 September 2013 it was reported as follows:

- "Significant further progress has been made since the July Parish Council Meeting including e) the completion of assessments from reports by three external consultants in relation to fire risk, legionella and health and safety. Although the list of recommendations is lengthy the high priority list is limited as set out below. None of the consultants have suggested that any of the current failings are sufficiently serious to require the temporary closure of the facility".
- f) Steven Whybrow was thanked for all his hard work and the council resolved to authorise a further £1,000 for further work by consultants.
- As to a way forward the council unanimously resolved that rather than appoint a manager g) responsible for the premises reporting directly to the council, the council would prefer to grant a lease to a body who would thereafter run the premises on a non-profit making basis. Such a company would be a company limited by guarantee. Nominees for authority to serve on that company were discussed, Councillors Tracey Wells and Jean Pugh put themselves forward for potentially serving on that company. It was envisaged that Stephen Whybrow would be the Chairman and possibly Howard Gilbert also.
- The Council would pay for the setting up of this company. h)

Councillor Brentnall raised the question of whether the Camping Close Trust objectives could be considered broad enough to encompass the Sports & Social. This matter should be considered further.

Objection letter received from local resident as follows:

- The density of the housing is quite out of keeping with the rural nature of the site, particularly with regard to its immediate proximity to the Dedham Vale AONB. It would appear that the developer's prime consideration is uplift in value, as is the case in so many applications of this sort, with scant regard to local circumstances.
- The village has very few facilities no shop, post office, pub or doctor's surgery, a very poor bus service and little local employment. Residents therefore have to commute to Colchester for all these services.
- The proposed entrance to the site is from a small lane, Carter's Hill, opposite the entrance to Boxted St. Peter's Primary School and very close to a dangerous cross-roads. The increase in traffic, particularly in the morning when children are being dropped off at school, would make this lane very dangerous and congested.
- Essex County Council has recently imposed a huge number of extra children from outside the village on Boxted St. Peter's Primary School, requiring the building of extra classrooms and destroying the school's rural character. There is already no guarantee of a place for a Boxted child at the school, even before the proposed new housing.
- The proposed 'public space' is very small and of little use to the village as a whole, UNLESS it fronts a shop/post office/pub/doctor's surgery.

061/13 | **FINANCIAL UPDATE** Bank reconciliation as at 31/7/13 shows balances as follows:

Current Account £50660.17
Business Premium £ 8540.60
NDP Account £19753.75

Sports and Social Club £ 2169.99

Current account balances include first half year precept (£ 10357 received April 2013) and first half year revenue support grant (£1235). The balance also includes £32k from the Close Brothers investment account which was closed in May 2013 by Close Brothers who could no longer offer any interest on these accounts.

The Clerk is investigating an alternative investment account for these funds with Lloyds Bank, our existing bankers.

The first half yearly water bill totalling £240 has been paid and invoices are being prepared for the Village Hall and SSC to cover this.

The NDP account includes the remaining £15k government grant funding previously held by Colchester Borough Council which was released to the parish council in April 2013, as well as grant funding from Community Development Foundation in respect of planning and highways consultants fees. The funding received so far amounts to £2037, with the final 10% due on production of paid invoices. Further funding up to £7k in total may be available from this source for any further necessary NDP expenditure over coming months.

The Sports and Social Club account includes an amount of £2,000 transferred from parish council funds to prevent the SSC account going overdrawn which will be repaid to the PC as soon as 2013/2014 subscription invoices have been paid by the club users. The Clerk has yet to issue these invoices but expects them to be posted within the next few weeks. The budget summary of receipts and payments (circulated with this report) shows SSC income from 1/4/13 to 31/7/13 at £6120 against expenditure of £6290.

The new accounting software is up and running and on the advice of the auditor Camping Close charity accounts whose funds do not belong to the parish council are being monitored separately from parish council balances to avoid any confusion at year end.

The balance of the Camping Close account as at 31/7/13 is £52248.00 which includes a matured investment for £36k shown as income on the parish council accounts as Lloyds Bank transferred these funds to the parish council account in error – page 3 of the budget reports (code 41) shows these funds leaving the parish council being returned to the charity accounts. As detailed above suitable investment accounts with Lloyds are being investigated for these funds.

The budget summaries to 31/7/13 show budget income and expenditure is all within planned budgets. VAT has been reclaimed for the financial year ended 31/3/13 totalling £1669.64. Of this £1005.87 is to be transferred to SSC and £11.45 to NDP, representing VAT paid by SSC and NDP respectively over that year.
