23/99 Welcome and noting apologies.

Jamie Seakens welcomed everyone to the meeting and noted that Cllr Gene Pugh had submitted apologies and the clerk was absent due to illness. Cllr Steve Bays and Lee Smith were not present.

Cllr Dedhar took the meeting notes.

**23/100 Declaration of Interests** – None declared.

23/101 Public Participation Session

No members of the public were present.

23/102 Minutes of the last meetings of the Council held on 12<sup>th</sup> June 2023.

Councillors <u>resolved</u> to agree the minutes of the last meeting with a clarification to 23/99.2 to reflect that the clerk would bring back recommendations for reducing financial risk.

# 23/104 Planning Applications

.1 To consider commenting on the following applications and noting the decisions made:

The Council had no objection to the planning application and resolved not to submit any comments to the planning portal.

223183 01/02/2023 Anglian Water Pipeline, Proposed hybrid planning application for

Dedham to Great Horkesley section of the proposed Bury St Edmunds to Colchester Pipeline Scheme with full planning consent sought for a pipeline and associated above ground infrastructure; and outline consent for

above ground infrastructure

The Council <u>resolved</u> to submit a comment requesting that damage to the natural environment, wildlife habitat and established flora/fauna be minimised and mitigated.

•2 **Decisions** - Decisions made by Colchester Borough Council were noted.

•3 To establish a working group to start the review the current Neighbourhood Plan and propose changes and improvements.

There was agreement that a group should be established to push forward on changes to the Neighbourhood Plan and the establishment of a formal working group should be on the agenda of the next Parish Council meeting. There was a desire to look at protecting views of the Dedham Vale AONB, protecting hedgerows, protecting against light pollution including greater policy around the Dedham Dark Skies project, and protecting landscape character. In the meantime, the Council <u>resolved</u> to seek advice from Colchester City Council as to whether this work would constitute minor changes or require a full new Neighbourhood Plan project.

.4 To respond to the NG Norwich to Tilbury Pylon project consultation. Cllr Hunt would attend the consultation event in Langham and draft comments for Council's agreement.

- •3 To note the resident's correspondence regarding public footpath closure and to see if Cllr Barber at Essex County Council has an update. Cllr Barber was not present and Jon Hunt agreed to follow up with him for an update.

- •1 To receive the clerks report including a list of resolutions agreed at earlier Parish Council meetings and note progress to date on the following (full report see attachment). This was noted.
- •2 To note the Village Hall Management Committee meeting agreed minor improvements to the Village Hall including new acoustic absorbing noticeboards. This was noted.
- Training to note the recent Safeguarding Training and recognition that the clerk and/or councillors do not need DBS checks as they don't come into contact with children/vulnerable adults in the course of their work. Noted and agreed.
